

- The city contributes 80% or 90% of construction cost and the property owner contributing 20% or 10%



BACKGROUND

▶1993 – Council adopted Resolution No. 93:036 which established the collection of Public Art Fees.

>2020 - Chapter 17.112 of the Municipal Code establishes the public art requirements.

The City currently does not have a comprehensive Public Art Master Plan.

Enhances the appearance and cultural richness of Paramount.

➢Will provide guidance, articulate a vision and goals, and develop a collection strategy.








Request to approve a professional service agreement with MIG to prepare objective design standards citywide.



Paramount has a tradition of expecting high-quality housing developments



State law is limiting cities from reviewing housing proposals based on "subjective design requirements"



Objective design standards are specific requirements that apply to certain residential projects



Easier to interpret for all homeowners, builders, and others



Know beforehand what requirements apply to proposed development

OBJECTIVE DESIGN STANDARDS

Definition – Government Code Sections 65913.4 and 66300(a)(7)

Standards that involve no personal or subjective judgment by a public official and are uniformly verifiable by reference to an external and uniform benchmark or criterion available and knowable by both the development applicant or proponent and the public official before submittal.

Design Guidelines	Design Standards
Subjective	Objective
Recommendations, which may not be enforceable or have the "teeth" of regulations	Requirements, which are enforceable as regulations
Open to interpretation, difficult to measure or verify	Measurable and verifiable
Use words such as "should" or "may"	Use language such as "shall," "must," or "is required to"
Adopted by resolution	Adopted by ordinance



PURPOSE



- <u>Objective Design Standards</u> are intended to meet State law requirements and ensure high-quality housing
 - Multi-family housing
 - Mixed-use housing
 - Single-family residential housing ADUs and SB 9 projects



• Establish standards for site planning, architectural styles, materials, and open space

• Integral part of the Zoning Code (Title 17 of the Municipal Code)



ODS FIRM

- MIG, Inc. is a multidisciplinary firm that completed the Housing Element update and nearing completion on the Parks Master Plan
- Understanding of the community's design objectives and housing context
- If approved, MIG will begin the development of ODS within six months of receiving authorization



FUNDING

- The total amount will not exceed \$80,000
- Included in the FY 2023-2024 General Fund budget





RECOMMENDED ACTION

STRATEGIC OUTCOMES

Approve agreement with Moore Iacofano Goltsman, Inc. to prepare residential objective design standards citywide with the total amount not to exceed \$80,000 and authorize the Mayor or designee to execute the agreement.



BACKGROUND / TIMELINE

- March 2023 Willdan Energy Solutions
- November 2, 2023 Oral Report on Status of Analysis and Recommended Projects
- November 28, 2023 Follow up
 - Question on billing
 - No contract approval tonight
- December 12, 2023 Public Hearing
 - If approved, project can begin in late spring 2024

Neighboring Rate Comparison Analysis



City of Paramount average water bill is 48% lower than the regional average bill.

Takeaway

Plan to Reduce Billing Impacts to the Community

City of Paramount Residential Usage Analysis

Usage Analysis

- Average Paramount Single Family Residential Customer uses 1,700 CF (cubic feet) of water per 2-month billing cycle
- 25% of residential accounts will see no impact
- 75% of residential accounts will see an impact between 1% and 11% increase

Phased Billing Plan

- Residents that experience a bill increase of 1.5% or higher will be a part of the phased billing plan which will occur over 12 months
- After installation is complete, the new system will compare new bills to old bills and flag residents that have a 1.5% increase in their bill

<u>Bi-Monthly</u> Bill Impact Examples



25% of residential bills will see no impact.40% of senior citizen bills will see no impact.

Gradual Increase to Accurately Measured Consumption

Average Residential User (17 CCF)



Takeaway

Most increases are less than \$5 and will be gradually implemented over 2-3 billing periods.
