SUMMARY

The Planning Department is responsible for administration of the City's land development process and implementing the long-range vision of the Paramount General Plan and other City plans. Comprehensive planning and a dedicated staff have been instrumental in improving neighborhood and commercial quality of life as the City has committed to attractive design, diverse housing options, and healthful and sustainable development.

This oral report will summarize applications that the Planning Commission and Development Review Board reviewed and approved in 2023 and provide an update on other projects and activities. In addition to current planning activities, some long-range plans underway include the Clearwater Specific Plan, Commercial Design Guidelines, Residential Objective Design Guidelines, and Public Art Master Plan. Details will also include permits issued and inspections completed by the Building and Safety Division of the Planning Department.
