THE CITY COUNCIL OF THE CITY OF PARAMOUNT DOES HEREBY ORDAIN AS FOLLOWS:

<u>Section 1</u>. Sections 29-1 and 29-1.1 of the Paramount Municipal Code is hereby amended in its entirety as follows:

"Section 29-1. County Traffic Code Adopted.

Title 15 of the Los Angeles County Code, entitled "Vehicles and Traffic," being a code regulating traffic upon public highways, is hereby adopted by reference as the Traffic Code of the City."

"Section 29-1.1. Penalties; continuing violations.

The first and second violation of any provision of this Chapter may be cited as an infraction or punished as a misdemeanor. The third such violation shall be punished as a misdemeanor by a fine not exceeding \$500 or imprisonment for a term not exceeding six (6) months, or by both such fine and imprisonment. Such violations may also be redressed by civil action."

Each day that any violation of the Chapter continues shall constitute a separate offense.

<u>Section 2</u>. <u>Severability</u>. If any section, subsection, subdivision, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or otherwise invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have passed this Ordinance and each section, subsection, subdivision, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses or phrases be declared unconstitutional.

<u>Section 3</u>. <u>Effective Date</u>. This Ordinance shall take effect thirty days after its adoption, shall be certified as to its adoption by the City Clerk, and shall be published once in the Paramount Journal within 15 days after its adoption together with the names and members of the City Council voting for and against the Ordinance.

BACKGROUND

This item is an annual review of a Live Entertainment Permit of Mariscos Mi Lindo Sinaloa restaurant at 7610 Rosecrans Avenue in the M-2 (Heavy Manufacturing) zone. The subject restaurant is licensed by the California Department of Alcoholic Beverage Control (ABC) for "Type-41" sales, which allows for the sale of beer and wine for onsite consumption. Mariscos Mi Lindo Sinaloa opens for business Fridays and Saturdays from 8:00 a.m. to 12:00 a.m. and Sundays through Thursdays from 8:00 a.m. to 11:00 p.m.

At its December 1, 2015 meeting, the City Council approved a City Council Permit for live entertainment in the following formats (Attachment A):

- "Banda Sinaloense" (maximum 11-member) musicians on Fridays and Sundays from 6:00 p.m. to 11:00 p.m. – at designated performance area inside the restaurant.
- "Norteño" (maximum 5-member) musicians on Mondays, Wednesdays, Thursdays, and Saturdays from 2:00 p.m. to 11:00 p.m. throughout restaurant upon customer request.
- Hosted and self-service karaoke on Saturdays and Tuesdays from 6:00 p.m. to 11:00 p.m. on dates when musicians are not scheduled to perform – at designated performance area inside the restaurant.

Live entertainment began March 12, 2016, and since then the City Council has requested routine compliance reviews. The last compliance review for Mariscos Mi Lindo Sinaloa was on July 5, 2017 and City Council received and filed the report with the stipulation to conduct an annual review. The annual review was scheduled to be presented to the City Council in July 2018 but was postponed to January 2019 due to the business owner expressing to city staff the idea of making some modifications to the existing live entertainment format, which would have required a separate review of the new modifications to City Council. Although it was contemplated and e-mails were exchanged between city staff and the business owner, there was never a formal application submitted and staff has determined to proceed with the compliance review based on the original approved live entertainment format.

LAW ENFORCEMENT ACTIVITY

From July 5, 2017 to December 17, 2018, a total of nine law enforcement responses have occurred. However, only three out of the nine responses were related to the business establishment. Three calls were traffic related and three calls were noted as accidental alarm activation calls. The incidents related to the business establishment are summarized as follows:

ANALYSIS

According to the calls for service, the subject restaurant, with its combined live entertainment and on-site alcohol beverage consumption, has been operating in full compliance with all applicable conditions of approval.

RECOMMENDED ACTION

It is recommended that the City Council receive and file the report with the stipulation that city staff conduct an annual review of Mariscos Mi Lindo Sinaloa Restaurant Live Entertainment Permit.

Background

This application is a request for a City Council Permit to allow live entertainment at the Mariscos Mi Lindo Sinaloa restaurant at 7610 Rosecrans Avenue in the M-2 (Heavy Manufacturing) zone. The applicants have operated in the freestanding building since 2005 when they purchased the property from the owners of El Sabalo. In November 2011, the applicants acquired the adjacent property to the west, which is developed with a 1,330 square foot vacant commercial building and two legal nonconforming ("grandfathered") residential units, each 672 square feet in area. The subject restaurant is licensed by the California Department of Alcoholic Beverage Control (ABC) for "Type-41" sales, which allows for the sale of beer and wine for onsite consumption. Mariscos Mi Lindo Sinaloa opens for business Fridays and Saturdays from 8:00 a.m. to 12:00 a.m. and Sundays through Thursdays from 8:00 a.m. to 11:00 p.m. The applicants also operate Mariscos Mi Lindo Sinaloa locations in Glendale and Maywood.

Section 11-5 (n) of the Paramount Municipal Code states that a City Council Permit is required for live performances, including musicians and karaoke. Following the permit review process as administered by the Community Development Department, the City Council may grant or deny a request for a City Council Permit based on the impact that the proposed use will have on the public health, safety, or welfare. The City Council may also impose conditions upon a City Council Permit to ensure that the use is not in conflict with surrounding land uses.

Current Request

The applicants are requesting a City Council Permit to allow live entertainment in the following formats:

- "Banda Sinaloense" (maximum 11-member) musicians on Fridays and Sundays from 6:00 p.m. to 11:00 p.m.
- "Norteño" (maximum 5-member) musicians on Mondays, Wednesdays, Thursdays, and Saturdays from 2:00 p.m. to 11 p.m.
- Hosted and self-service karaoke on Saturdays and Tuesdays from 6:00 p.m. to 11:00 p.m. on dates when musicians are not scheduled to perform.

Banda Sinaloense musicians and karaoke participants would perform from a proposed 248 square foot performance area as indicated on the submitted site plan and floor plan (copies included), and the Norteño musicians would entertain customers throughout the restaurant upon request.

Previous Request

This is the second request for live entertainment from the applicants for 7610 Rosecrans Avenue. A City Council Permit was agendized for the September 4, 2012 City Council meeting, and staff prepared a report with a denial recommendation due to a number of factors, including six calls for service in the previous two years for unruly patrons, an unpermitted bathroom inside the restaurant, the unauthorized removal of mature trees from the front landscape area of 7600 Rosecrans Avenue, and the determination that two of four residential units at 7600 Rosecrans Avenue were unpermitted. However, on the date of the City Council meeting, the applicants requested that the application be withdrawn from the agenda, and the Council acted accordingly.

In the months since the previously scheduled City Council review, the applicants have resolved the bulk of the abovementioned issues. The owners legalized the unpermitted restroom construction, planted replacement trees, and construction is progressing to restore the four housing units to the permitted two.

Law Enforcement Activity

As we do with all live entertainment requests, we reviewed law enforcement activity at this location. Since the previously withdrawn request in 2012 for live entertainment, the following incidents with responses from the Sheriff's Department and/or Code Enforcement Division occurred:

- November 4, 2012 A Sheriff's deputy observed a live band playing inside the restaurant.
- April 20, 2013 The Sheriff's Department responded to a report of a parked vehicle with three people who refused a request by the restaurant manager to leave the premises. The disturbing parties had left prior to Sheriff's Department arrival.
- May 10, 2013 An informant reported multiple threatening and annoying calls. The Sheriff's Department was unable to substantiate evidence of criminal threats.
- September 27, 2013 Restaurant staff reported an intoxicated customer who refused to pay. The disturbing party had left prior to Sheriff's Department arrival.
- April 13, 2014 A Sheriff's deputy issued a warning to a customer who refused to pay for music requested of the live band.
- May 22, 2014 An informant stated that his vehicle was stolen. The Sheriff's Department filed a report.
- January 16, 2015 A group of five-to-seven people were fighting; one of the group crashed through a front window of the restaurant. The Sheriff's Department filed a report.
- February 6, 2015 Code Enforcement and the Sheriff's Department joined ABC for random inspections throughout Paramount. Code Enforcement observed a live band and lighting installed inside the restaurant. Code Enforcement issued a Notice of Violation for the unpermitted entertainment and interior light fixtures on March 10, 2015.

- March 1, 2015 An intoxicated individual demanded change for a taxi from restaurant employees. The Sheriff's Department made contact with the disturbing party and released him to his mother.
- July 12, 2015 Code Enforcement observed a band playing at the restaurant and followed up with a citation on July 13, 2015.
- August 8, 2015 A patrol check for live entertainment resulted in the observation of a Norteño band ("911 Emergencia"). The restaurant manager stated that the band would immediately cease playing. Code Enforcement issued a citation on August 10, 2015 for the incident.

No additional incidents have been reported or observed since August 8, 2015.

Discussion

As required by the Municipal Code, the Community Development Department, Public Safety Department, and the Los Angeles County Sheriff's Department have reviewed the application, including site plan and floor plan. Representatives from each department and the Deputy District Attorney assigned to Paramount met with the applicants in person on November 9, 2015 and November 17, 2015. The compatibility of noise from musicians in relation to the adjacent residential units was discussed, and the applicants stated that they try to minimize noise while trying to secure tenants with an appreciation for music. In support of the applicant statements, a review of activity at the site in the last three years indicates no noise complaints.

Recommended conditions, each of which were reviewed line-by-line with the applicants, will prevent music and singing from disturbing neighboring tenants or property owners. Although security cameras have been installed on the interior and exterior of the building, a condition has been included to ensure superior camera positioning and law enforcement access to recordings. A licensed security guard will be required onsite during the hours of entertainment. Further, loitering in the parking lot will be expressly prohibited, and all doors will be required to remain closed during the hours of operation except for the entering and exiting of customers and employees. A City Council review three months after the permitted live entertainment commences is recommended as a condition to ensure the long-term compliance of the conditions of approval and safeguard the surrounding businesses and tenants.

The location of the restaurant within a heavy manufacturing zone and the proposed evening entertainment hours after standard business hours offer suitable land-use and time buffers to minimize conflicts with most residents and businesses. Although the two neighboring residential units at 7600 Rosecrans Avenue could appear to be incompatible with live entertainment at a restaurant, the lack of noise complaints over the course of years and the applicants' apparently successful control of the site suggest otherwise.

Although public safety incidents continued beyond the first application in 2012, the applicants have demonstrated a willingness to address past issues by legalizing unpermitted construction and planting trees. Additionally, restaurant management reported the more egregious of the incidents summarized above to the Sheriff's Department, indicating an inclination to cooperate with law enforcement. With the exception of the fight on January 16, 2015 that resulted in damage to the building, most occurrences are typical of a restaurant with the sale of beer and wine, and we would be more concerned if the owners had neglected to notify the Sheriff's Department of the incidents. The applicants have admitted to faultily allowing unpermitted live

entertainment, and they have ceased the practice. Finally, the applicants understand that not complying with all conditions of this permit will jeopardize their ability to provide live entertainment.

Recommended Action

It is recommended that the City Council read by title only and adopt Resolution No. 15:031, approving a City Council Permit for live entertainment at Mariscos Mi Lindo Sinaloa at 7610 Rosecrans Avenue, subject to the following conditions:

- This City Council Permit shall not be effective for any purposes until the business owners have filed at the office of the Community Development Department their affidavit stating that they are aware of and accept all conditions of this permit. The affidavit shall be submitted by Friday, December 18, 2015. The City Council Permit shall not be effective until all conditions are addressed.
- If either the Community Development Director or Public Safety Director determines that the operation of the business negatively impacts the public peace, health, safety, or general welfare, the City Council shall have the authority to review the City Council Permit. The City Council may revoke, suspend, or modify the Permit in order to protect the public peace, health, safety, and general welfare.
- The City Council shall review the status of compliance with the approved conditions at the first City Council meeting three months after permitted live entertainment performances commence.
- The applicant shall meet all requirements and conditions of the Department of Alcoholic Beverage Control (ABC).
- Live entertainment shall be permitted inside the restaurant with the following formats, days, and hours:
 - a. Banda Sinaloense (maximum 11-member) musicians on Fridays and Sundays from 6:00 p.m. to 11:00 p.m. within the designated performance area;
 - b. Norteño (maximum 5-member) musicians on Mondays, Wednesdays, Thursdays, and Saturdays from 2:00 p.m. to 11:00 p.m. within the dining area of the restaurant;
 - c. Hosted and self-service karaoke on Saturdays and Tuesdays from 6:00 p.m. to 11:00 p.m. within the designated performance area on dates when musicians are not scheduled to perform.
- 6. No change or alteration to the approved entertainment format shall occur without prior written approval from the City of Paramount.
- 7. All live entertainment shall be directly contracted through the business owners. Entertainment and other events produced by independent promoters are prohibited.

- A minimum of one security guard in possession of a valid security guard registration from the Bureau of Security and Investigative Service shall be onsite during the hours of live entertainment until the business is closed and until all patrons have vacated the premises. The guard shall be plainly identifiable by uniform and shall patrol the parking lot at least twice each hour as needed. The guard shall be independent of the business and business interests of the owners.
- 9. The Public Safety Department shall review and approve the security camera locations and orientations, including comprehensive camera views of the establishment interior, exterior, and parking lot. The business owners shall maintain the approved security camera system, including network video recorder (NVR), in good working condition in perpetuity. The equipment shall be utilized at all times during normal business hours. In the event of an incident and upon request, the business owners shall allow unimpeded inspection of the security camera system to City representatives.
- 10. The live entertainment provided shall not be audible beyond the area under control of the applicant. The live entertainment shall not disturb the neighbors. No amplified sound equipment shall be installed on the exterior of the building.
- 11. All doors shall be kept closed during the live entertainment hours except for immediate ingress and egress.
- 12. During the hours of live entertainment, an owner, the manager, or a designated responsible person 21 years of age or older shall be on the premises and shall be responsible for the operations during the hours of live entertainment. This person shall possess on his or her person a valid driver license or identification card issued by the California Department of Motor Vehicles (DMV). This person shall also be able to communicate effectively with regulatory officials and have the ability to immediately contact the owner. The person will immediately introduce himself or herself to any regulatory officials.
- 13. The owners, managers, and persons designated to be responsible for the operation of the business shall cooperate fully with all city officials and law enforcement personnel, and shall not obstruct or impede their entrance into the licensed premises while in the course of their official duties. Any locked or otherwise secured rooms shall be opened upon demand.
- 14. All employees shall possess at the site a valid driver license or identification card issued by the California Department of Motor Vehicles (DMV). They shall present such identification upon demand by any regulatory official.
- 15. An active City of Paramount business license shall be maintained current with prompt annual renewals.
- 16. The maximum number of occupants shall be established by the Fire Marshall according to each specific entertainment use and floor plan. A maximum occupancy placard shall be posted in a conspicuous location on the premises. This occupancy limitation shall not be violated.

- 17. It shall be unlawful for any person who is intoxicated or under the influence of any drug to enter, be at, or remain upon the licensed premises as set forth in Section 25602(a) of the Business and Professions Code.
- 18. The person designated to be responsible for the operation of the business shall not perform official police or investigative activities but shall immediately report every violation of law and every unusual occurrence to the Sheriff's Station.
- 19. No employee or agent shall solicit or accept any alcoholic or non-alcoholic beverage from any customer while on the premises.
- No self-service of alcoholic beverages shall be permitted.
- 21. Any graffiti painted or marked upon the premises or on any adjacent area under the control of the licensee shall be immediately removed or painted over to match the predominant surface color.
- 22. The approved floor plan shall not be changed without prior approval by the Community Development Department and the Sheriff's Department.
- 23. No obstructions or partitions shall be attached, fastened, or connected to separate the interior space of the licensed premises.
- 24. No outside loitering shall be allowed on the premises. A professionally fabricated sign indicating as such shall be posted following Public Safety Department review and approval of the content and location.
- 25. The business owner(s) and property owner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
- 26. All required permits and licenses from all relevant regulating bodies shall be valid at all times. A copy of all licenses, permits, and conditions shall be posted and maintained in a place conspicuous and readable by all employees and customers of the location.
- 27. No employee or agent shall be permitted to accept money or any other thing of value from a customer for the purpose of sitting or otherwise spending time with customers while on the premises, nor shall the licensee provide, permit, or make available male or female persons who act as escorts, companions, or guests of and for the customers, either with or without compensation.
- 28. No pool or billiard tables shall be maintained on the premises.
- 29. The outside consumption of alcoholic beverages is prohibited.
- 30. Food shall constitute the majority of the gross sales at the restaurant.
- 31. The sale of beer and wine shall be for onsite consumption only.

- 32. A single jukebox may be maintained upon the premises; however, the music shall not be audible outside the premises.
- 33. Human signs, sign walkers, and sign spinners are prohibited on the property and the public rights-of-way.
- 34. Special events shall be reviewed in accordance with Special Event Permit regulations by the Community Development Department. The applicant shall submit a Special Event Permit application at least two weeks in advance of a proposed event.
- 35. A licensed contractor shall obtain the required permits from the Building and Safety Division for unpermitted lighting. The contractor shall request a field inspection and obtain final approval.
- 36. Future tenant improvements shall meet all requirements of the Building and Safety Division.
- 37. Landscaping shall be maintained in a thriving, clean condition for perpetuity. Trees shall be trimmed in accordance with Section 44-112 of the Paramount Municipal Code. Mature trees shall not be removed without written authorization by the Community Development Department.
- 38. The charitable donation bin shall be completely removed from the site.
- 39. Solicitors, peddlers, hawkers, ltinerant merchants, and transient vendors of merchandise are prohibited.
- 40. The premises shall not be leased or rented for private parties.
- 41. Final approval by the Community Development Department is required before live entertainment shall be permitted. All conditions of approval shall be met prior to final approval by the Community Development Department.
- 42. Revisions to an existing City Council Permit require separate review and approval by the City Council. City Council Permits expire upon sale or transfer of the business to a new business owner.
- 43. Failure to comply with the above conditions and/or any applicable laws shall be cause for the modification, suspension, or revocation of this permit.

ASSISTANCE GRANT (JAG) FUNDING 2018-2019

For the past twenty-two years, the City of Paramount has received Federal funding to supplement local law enforcement via a combination of grants. The current funding comes from the Bureau of Justice Assistance Grants, with previous funding coming from Local Law Enforcement Block Grants. In the past, we have used this money to fund deputy personnel and to purchase equipment. The Edward Byrne Memorial Justice Assistance Grant or JAG grant has been awarded to the City of Paramount for the last twelve years for a total of about \$406,506. The award total can vary widely between cities, from year to year, and is determined by a formula that considers population, crime statistics, and state allocation. This year, the City's allocation is \$20,809.

There is no local match required. The grant requires the City to: 1) develop a proposed use of funding, 2) conduct a public hearing to discuss the proposed use of funds, and 3) prepare quarterly financial and programmatic reports.

A Public Hearing Notice was published in the Paramount Journal on December 20, 2018.

PROPOSED FUNDING USAGE

Probation Compliance Checks – The City will fund probation compliance checks with the assistance of the Paramount Special Assignment Officer (SAO) team. The team will follow up on probationers with warrants, or probationers suspected of being involved in criminal activity.

Parole Compliance Checks – Deputies will conduct parole compliance checks. Parolees with arrest warrants or who are subject to search, will be contacted. Conducting the searches will ensure that parolees living in Paramount are supervised.

Truancy Sweeps – The Paramount SAO team will work to detain juveniles who are absent from school without excuse. Truants who are contacted during the sweeps will be cited, returned to school, and a letter will be sent to the parent/guardian. These sweeps alert parents of their children's conduct.

Curfew Sweeps – The Paramount SAO team will work to detain juveniles who are unsupervised in public after curfew. Juveniles contacted during the sweeps will be cited and returned home. Again, this type of operation will alert parents to the actions of their children and require them to address this type of behavior. Enforcement of curfew should also reduce nighttime criminal activity related to juveniles.

RECOMMENDED ACTION

It is recommended that the City Council conduct a public hearing and authorize the use of the grant funds to pay for the programs specified in this report.

MAINTENANCE FOR FY 19

On December 18, 2018, the Director of Public Works opened and examined the bids for hardscape concrete maintenance for FY 19. The bids were opened at 11:00 a.m. in the City Hall Council Chambers. This contract is for on-call curb, gutter and sidewalk repairs for the remainder of the fiscal year for an amount not to exceed \$150,000 as approved in the FY 19 budget. The contract has an option to extend it administratively in future years allowing only an annual Consumers Price Index (CPI) adjustment with a maximum of 4%.

In previous years, this was handled as a Capital Improvement Project (CIP), where a list of sidewalk and curb repairs were compiled and constructed at one time. However, as we have experienced in the past, curb, gutter, and sidewalk repairs are needed throughout the year and more cities are opting for an on-call hardscape concrete maintenance contractor to handle these repairs as the need arises. This will allow us to still secure a competitive price and have a more efficient response to eminent repair needs throughout the year.

One (1) bid was received and was submitted by CJ Concrete Construction Inc. The bid was noticed in the Paramount Journal and specifications for the project were picked up by three contractors. CJ Concrete Construction Inc. was the only contractor to submit a bid. Public Works staff analyzed the bid and determined the pricing is consistent with the most recent street projects completed in the city as well as current industry standard pricing. Additionally, CJ Concrete Construction Inc. has similar contracts with surrounding municipalities including Lakewood and Long Beach.

RECOMMENDED ACTION

It is recommended that the City Council award the contract for hardscape concrete maintenance for FY 19 to CJ Concrete Construction Inc., Santa Fe Springs, California, in the amount of \$150,000, and authorize the Mayor or her designee to execute the agreement.

Programming

On March 20, 2018, the City Council approved a comprehensive agreement with the Los Cerritos YMCA that provides an annual allocation for the YMCA to provide a youth basketball program at the Paramount Gym, an after-school program at the Mariposa Center, participation in their Camp Oakes summer program, and swim lessons at Paramount Pool. This agreement provides for expansion and growth in additional YMCA services as necessary and agreed upon.

The YMCA successfully completed their first youth basketball program in Paramount last year and will start the second year of that program this February. They initiated their after-school program at Mariposa in the 2018-2019 school year and will be offering this program again for the 2019-2020 school year for parents that require an after-school care option outside of the STAR program. The YMCA also successfully completed their first year of swim lessons this past summer and was able to extend lessons for many Paramount families into the fall, something the City never offered before. With the successful entry of the YMCA into our youth services programming, we are proposing an expansion of their services in Paramount to now include the operation of our summer recreation swim services.

The inclusion of recreation swim into the YMCA's aquatic services in Paramount will provide for efficiencies in their operations and provide the City with quality service for our residents. The YMCA offers swim lessons in the morning and then later in the afternoon/evening. The City recreation swim operates between the two sets of lessons. Therefore, should the YMCA take over recreation swim, this would allow better continuity of lifeguard assignments for the YMCA. The YMCA national lifeguard guidelines for recreation swim are also more stringent than the Red Cross guidelines the City currently follows. The YMCA guidelines require one lifeguard per 25 in-water pool participants whereas our rules require one lifeguard per zone of observation and control. The YMCA guidelines will provide an even safer pool environment for our residents.

Based on last year's cost of providing recreation swim services, the City incurred a net cost of approximately \$45,000. We are recommending that we allocate this amount to the YMCA, in addition to their current \$25,000 allocation to operate their existing youth services in our community, to assist them in providing recreation swim services. This relieves the City of additional general fund part-time expenses that will only continue to grow as the State's minimum wage law continues to be phased in incrementally over

the next few years. There will also be indirect savings as a result of this proposed contracting of services that will benefit Human Resources (reduced recruitment and personnel management), Finance (reduced payroll maintenance), and Recreation (reduced supervision), as well as direct savings in supplies and uniform costs associated with the aquatics budget.

The YMCA's liability requirements will require that anyone participating in recreation swim complete a YMCA liability waiver form. The YMCA will conduct outreach in the community to have residents complete this form prior to the start of summer swim. Residents will receive a YMCA key tag that will be scanned when they enter the pool and will identify them as residents and, therefore, make them eligible for the current resident pool entry rate. Non-residents that complete the form will continue to pay the non-resident fee rate. There is no anticipated increase to our resident fee rate but the YMCA will likely request a fee increase for non-resident use. All requested fee increases will require prior approval by the City.

Attached is the amended agreement with the YMCA for use of City facilities to operate youth programming to include recreation swim.

RECOMMENDED ACTION

It is recommended that the City Council authorize the City Manager or his designee to amend our existing agreement with the YMCA to provide use of City facilities for recreation swim services.

AGREEMENT BY AND BETWEEN THE CITY OF PARAMOUNT AND THE LOS CERRITOS YOUNG MAN'S CHRISTIAN ASSOCIATION (YMCA) TO PROVIDE USE OF CITY FACILITIES TO OPERATE VARIOUS YOUTH PROGRAMS AS APPROVED BY THE PARAMOUNT CITY COUNCIL

I. RECITAL

A. <u>PURPOSE</u>. The purpose of this Agreement is to provide for the use of CITY facilities to the YMCA for the operation of mutually agreed upon youth programs ("Programs"). This Agreement is made and entered into with respect to the following facts:

- (a) CITY agrees to allow the YMCA to operate Programs that consist of a youth basketball program, an after school youth program, youth swim lessons, and any further youth programs as authorized and approved by both the CITY and YMCA through amendment of this agreement.
- (b) CITY is the owner of certain real property ("Property 1") which is located in the City of Paramount at 14400 Paramount Blvd. and which contains the Paramount Park Gymnasium, outdoor basketball courts, and pool; and
- (c) CITY is the owner of certain real property ("Property 2") which is located in the City of Paramount as 15500 Downey Ave. and which contains the Progress Plaza East building; and
- (d) CITY has access to various gymnasiums per a Joint Use Agreement with the Paramount Unified School District in which CITY is able to conduct CITY-sponsored sports programs; and
- YMCA has experience and expertise with a wide variety of youth programs, including basketball programs, swim lessons, and after school care; and
- (f) The parties have agreed that the following Programs organized by the YMCA shall operate at the following facilities: a youth basketball program at the Paramount Park Gymnasium, Paramount Park outdoor basketball courts, and the Paramount High School West Gymnasium; a youth swim

lesson program at Paramount Park Pool; and an after school care program at Progress Park East is to their mutual benefit and is in the best interests of the residents of the CITY; and

(g) The City Council of CITY has determined that the public interest, convenience and necessity require the execution of this Agreement.

II. TERMS AND CONDITIONS

- B. <u>TERMS</u>. This Agreement shall commence on the first day of ______, 2019, and shall continue until such time that either party gives written notice of termination in accordance with the provisions set forth in Section II.G.
- C. <u>SERVICES</u>. YMCA shall supply all necessary services and personnel in order to conduct its youth basketball program, youth swim lessons, and after school care as contemplated pursuant to this Agreement, during the term of this Agreement. YMCA shall provide for a qualified Program coordinator who shall supervise the Program and shall have overall responsibility for the operations of the Program, including the employment, training and supervision of staff qualified and sufficient to safely operate the Program. All YMCA staff must be trained and certified in the safety courses listed below.
 - American Red Cross CPR
 - American Red Cross Title 22 First Aid

YMCA shall be responsible for all administration relating to the conduct of the Program, including, but not limited to, registration of classes included in the Program, organization and implementation of the Program, and the promotion of the Program to members of the public within the CITY (collectively "Services").

- D. <u>CITY'S OBLIGATIONS</u>. CITY shall make available to YMCA for the purpose of conducting the Program, that portion of Paramount Park Gymnasium and outdoor basketball courts, the Paramount High School West Gymnasium authorized by the Joint Use Agreement between the City and the Paramount Unified School District, Paramount Park Pool, and Progress Plaza East as reasonably necessary to accommodate the Program and the administration thereof. CITY shall, during the term of this Agreement, maintain these facilities in good condition for such usage, and shall provide all utilities and other facility supplies necessary for said usage; provided, however, that CITY'S obligations for any maintenance of the Paramount High School West Gymnasium is limited to its obligations contained in that Joint Use Agreement with the Paramount Unified School District.
- E. <u>USE OF THE FACILITIES</u>. YMCA shall be entitled to the use of that portion of Paramount Park Gymnasium and outdoor basketball courts, the Paramount High School West Gymnasium, Paramount Park Pool, and Progress Plaza East as described in Section II.C & II.D, hereinabove, and which the CITY'S Community Services &

Recreation Director deems reasonably necessary for the purpose of conducting the Program. The parties shall mutually agree on the days and hours during which the Program will be provided.

- F. <u>COMPENSATION</u>. YMCA shall be entitled to charge participants in the Program reasonable fees for registration and participation therein. Said fees shall be mutually agreed upon the by both the CITY and the YMCA. The YMCA shall be entitled, as compensation for its Services hereunder, to retain the fees charged to participants of the Program.
- G. <u>TERMINATION</u>. Either party hereto may at any time during the operation of this Agreement, terminate this Agreement in writing upon One Hundred and Twenty (120) days notice to the other party. Termination pursuant to such a notice shall be effective on the One Hundred and Twenty First (121st) day following the giving of such notice.

Upon termination of this Agreement as provided for herein, YMCA shall vacate Paramount Park Gymnasium, the outdoor basketball courts at Paramount Park, any gymnasiums authorized under the Joint Use Agreement between the City and Paramount Unified School District, the Paramount Park Pool, and Progress Plaza East as of the effective date of such termination.

- H. <u>FACILITY DAMAGE</u>. Any damage to the athletic facilities under this Agreement caused by YMCA or any of its agents or employees whether through acts of negligence, omissions to act where a duty to act exists, or by intentional conduct shall be the sole responsibility of the YMCA to pay. YMCA acknowledges and hereby agrees it shall reimburse CITY for any and all work or repairs required to be done to correct any such damages to the facilities within thirty (30) days upon receipt of invoice from CITY.
- I. <u>INSURANCE</u>. YMCA, at its sole cost and expense, for the entire time of this Agreement, shall obtain and maintain at minimum all of the following insurance coverage:
 - (a) Types of Insurance and Minimum Limits. The coverage may be satisfied by any combination of specific liability and excess liability policies.
 - (1) Workers' Compensation and Employee Liability Insurance in conformance with the laws of the State of California for the statutory limits.
 - (2) Vehicle insurance, including owned, non-owned (e.g. used by YMCA's employees in the course and scope of employment), in the minimum amount of One Million Dollars (\$1,000,000.00) combined single limit per accident for bodily injury and property damage.

- (3) Comprehensive or commercial General Liability Insurance coverage which shall include, but not limited to, coverage for premises operation, explosion and collapse hazard, underground hazards, contractual insurance, broad form property damage, independent contractors, and personal injury liability. The limit of such insurance shall be at least Two Million Dollars (\$2,000,000.00) combined single limit liability for personal injury and property damage.
- (b) The CITY and its officers and employees shall be named as additional insured by endorsement (except for workers' compensation) at no cost to the CITY.
- (c) Prior to providing any services under the Agreement, YMCA shall furnish proof to the CITY that satisfactory policies of insurance described above are in place. All insurance policies shall be issued by an insurance company currently authorized by the Insurance Commissioner to transact business of insurance or is on the List of Approved Surplus Line Insurers in the State of California, with an assigned policyholders' Rating of A- (or higher) and Financial Size Category Class VII (or larger) in accordance with the latest edition of Best's Key Rating Guide, unless otherwise approved by the CITY'S Risk Manager.
- (d) All insurance policies shall provide that in the event of material change, reduction, cancellation, or non-renewal by the insurance carrier for any reason, not less than thirty (30) days notice will be given to the CITY by registered mail of one (1) copy of a written notice of such intent to cancel or not to renew the coverage. An authorized agent of such insurance carrier shall provide to the CITY, on such schedule as is reasonably requested by the CITY, a certification that all insurance premiums have been paid and all coverage is in force. If for any reason, YMCA fails to obtain or keep such insurance in force, the CITY may, but shall not be required to, obtain such insurance, in which event YMCA shall promptly reimburse the CITY'S premium cost therefor plus one and one-half percent (1 ½%) monthly interest thereon until paid.
- (e) Requirements of specific coverage features or limits contained in this Section are not intended as a limitation on coverage, limits or other requirements, or a waiver of any coverage normally provided by any insurance. Specific reference to a given coverage feature is for purposes of clarification only as it pertains to a given issue and is not intended by any party or insured to be all inclusive, or to the exclusion of other coverage, or a waiver of any type. If the YMCA maintains higher limits than the minimums shown above, the CITY requires and shall be entitled

to coverage for the higher limits maintained by the YMCA. Any available insurance proceeds in excess of the specified minimum limits of insurance and coverage shall be available to the CITY.

J. <u>INDEMNIFICATION</u>. To the fullest extent of the law, the YMCA shall indemnify, defend, and hold harmless CITY, its officers, employees, and agents from any and all losses, costs, expenses, claims, liabilities, actions, or damages, including liability for injuries to any person or persons or damage to property arising at any time during and/or arising out of or in any way connected with the YMCA's use or occupancy of the athletic facilities and adjoining property, unless solely caused by the gross negligence or willful misconduct of the CITY, its officers, employees, or agents.

CITY does hereby agree to defend, indemnify and hold free and harmless, YMCA, its officers, employees and agents from and against any claim made by a person, including claims, demands, or judgements (collectively "Claims") in favor of any person which arises out of the performance by CITY of its obligations pursuant to this Agreement, including, but not limited to, a failure to act by CITY where a duty to act exists, unless solely caused by the gross negligence or willful misconduct of the YMCA, its officers, employees or agents.

- K. <u>INDEPENDENT CONTRACTOR</u>. YMCA shall be deemed, for all purposes, to be an independent contractor and shall not be considered an employee of the CITY or under CITY supervision or control and shall not be authorized to bind CITY in any way. This Agreement is by and between the YMCA and the CITY, and is not intended, and shall not be construed to create the relationship of agent, servant, employee, partnership, joint venture, or associate, between the CITY and the YMCA.
- L. <u>SUCCESSOR AND ASSIGNMENT</u>. The services as contained herein are to be rendered by the YMCA whose name is as appears first above written and YMCA shall not assign or transfer any interest in this Agreement without prior written consent of the CITY.
- M. <u>NOTICES</u>. Whenever notices are required to be given pursuant to the provisions of this Agreement, the same shall be in written form and shall be served upon the party to whom addressed by personal service as required in judicial proceedings, or by deposit of the same in the custody of the United States Postal Service or its lawful successor in interest, postage prepaid, addressed to the Parties as follows:

- O. <u>INTERPRETATION</u>. No provision of this Agreement is to be interpreted for or against either party because that party's legal representative drafted such provision, but this Agreement is to be construed as if it were drafted by both parties hereto.
- P. <u>MODIFICATION</u>. This Agreement shall not be modified except by written agreement of both parties.

Subject: DEVELOPMENT ACTIVITY UPDATE

The Community Development Department is pleased to report the following notable development activity in Paramount:

COMMERCIAL PROJECTS

Clearwater Crossing (15754 Paramount Boulevard/8009 Alondra Boulevard – N/E corner of Paramount Boulevard/Alondra Boulevard)

The grand opening of Stinkin Crawfish on November 20 marked the completion of this capstone Downtown Paramount project. The owners of Stinkin Crawfish and the Pizza Press in particular have happily informed us that business has far surpassed their expectations, and Paramount residents and employees regularly enjoy the open patio and pedestrian-friendly design.





Horchateria Rio Luna (15950 Paramount Boulevard)

Construction continues on the project to transform the former bank (most recently dance studio) space to the flagship location for Horchateria Rio Luna. Their second location opened in San Fernando last month.





IHOP (16230 Paramount Boulevard) - COMMERCIAL REHAB

IHOP was a City-funded Commercial Rehabilitation project and has been open for just over a year. The owners state that business is outstanding and are very appreciative of the support of the Paramount community. Interestingly, Paramount late-morning sales are unusually high compared to other locations. The before and after photos below show a new paint scheme throughout, matching metal louvers, stone veneer on the existing columns, wood panels, decorative metal awning at the front entry, decorative lighting, and new wall signs.





Brucker Project (15957-75 Paramount Boulevard) – COMMERCIAL REHAB

This completed City Commercial Rehabilitation project brought a contemporary look to two office/commercial buildings in Downtown Paramount. The remodel included a new paint scheme throughout, matching laser-cut metal awnings and wall panels, decorative lighting, new wall signage, new tile roofing on the mansards, and the refurbishment of the existing monument sign.





Magaña and Montenegro Project (15332 Paramount Boulevard)

The 2,560 square foot two-story office building at the vacant lot where fire-damaged residential structures were demolished in 2010 was completed earlier this year.





Orange Mafa, LLC Project (16412 Orange Avenue)

The remodel of the three-suite retail building, formerly occupied by Shotz Bar, received a final inspection in early December. Decorative stone veneer was applied, metal awnings were installed, and the landscaping was updated.





Five Star Market (14107-13 Downey Avenue, between Elburg Street and Wilbarn Street)

Construction plans for a new development at the current site of the Five Star Market were submitted to the Building and Safety Division for plan check. A four-suite structure will replace the existing deteriorated buildings. The elevations of the building will feature a combination of stucco and cultured stone, various wall projections, cornice, a prominent entry feature to the market to add architectural interest, a metal-clad sunshade, storefront windows, and decorative lights.



Jack in the Box (8433 Alondra Boulevard, near Downey Avenue)

The Development Review Board approved a remodel of the Jack in the Box on Alondra near Downey. The architect is touching up construction plans before submitting them for plan check.





Candiotty Project (13913 Paramount Boulevard, near Pearle Street) - COMMERCIAL REHAB

Construction plans are approved and bid packages are being prepared for the City Commercial Rehabilitation project for the long-vacant front building and property. Once the low bidding contractor is determined, the City Council will review the award of contract. The property owners are addressing the rear building and parking lot separately.





RESIDENTIAL PROJECTS

Magnum Property Project (8321-35 Somerset Boulevard – N/W corner of Indiana Avenue/ Somerset Boulevard)

After months of delays due to the developer's issues with the contractor and architect, the eight-unit residential project is finally making progress. The developer bought the properties in December 2016 and has expressed an eagerness to finish and recoup his investment. Problems with the foundations have been resolved, and the contractor continues with framing.





Gold Key Development Project (Rancho Caballo, Rancho Parada, Rancho Portillo) The 30-unit single-family home project on former horse stable properties and underutilized portions of the Home Depot parking lot is done and all properties are sold.





Gold Key Development Project (14930-52 Texaco Avenue – N/E corner of Texaco Avenue/Somerset Boulevard)

Following recent City Council approval of the general plan amendment and zone change to allow for the development, construction is underway for the 12-unit housing project for the vacant site at the northeast corner of Somerset and Texaco. The contractor/owner has constructed the perimeter block walls with vines and is starting with six homes.





Echemendia Project (15301-09 Gundry Avenue)

Four infill homes are under construction on this project that the Development Review Board approved a little over a year ago. The homes will include a stucco exterior with medium texture, ledgestone wainscot, multilevel roof lines with flat concrete tile, varying building insets and projections, window trim, and shutters. The owner will provide a common barbecue area and tot lot.





Drs. Henein and Kamel Project (15158-15302 Orange Avenue)

Eleven units are under construction on this property that happens to adjoin (back to back) the Gundry Avenue project noted on the previous page. The design of the units includes a two-color stucco exterior, ledgestone veneer accents, and multilevel roof lines with clay tile. The owners will install a children's playground and two barbecue areas.





INDUSTRIAL PROJECTS

StorQuest (7540-48 Rosecrans Avenue)

The new self-storage facility that replaces the Los Compadres Tortilleria is almost complete. The building facades incorporate varying building projections, metal wall finishes, metal clad canopies applied to a portion of the north and west elevations, and an expansive use of glass. Drought tolerant landscaping will be planted in a new front planter that extends 30 feet inward from the sidewalk.





J-Jr. Drywall Systems (7713 Madison Street)

The owner/contractor completed a 2,370 square foot warehouse and office building several months ago. The contemporary design with decorative metal mesh on the west side of the front elevation is a distinct architectural improvement.





GDM (15526 Vermont Avenue)

The contractor will soon be working on exterior finish work for a new building on a vacant 7,500 square foot lot. The front elevation will include a sand stucco exterior with decorative insets, a dual glaze anodized aluminum window, and a recessed roll-up door. The property will be landscaped with drought tolerant plants.






Bousema Project (16223-29 Illinois Avenue)

Construction plans are in plan check for this project to demolish a legal nonconforming house in the Central Industrial District and construct a 10,432 square foot five-suite building for industrial tenants.





RECOMMENDED ACTION

It is recommended that the City Council receive and file this report.
