# Workforce Development Boards

- County of Los Angeles Workforce Development Board
  \* LACO-WDB controls operations and funding for job recruitment and placement centers
  - \* Serves 58 cities in the County
- Independent Workforce Development Boards
  - \* Receives funding directly from the state
  - \* Operates job recruitment and placement centers for 30 cities not part of the LACO-WDB
  - \* Southeast Los Angeles County (SELACO) WDB

# **SELACO** Application

• City of Paramount part of LACO-WDB

- February 2019 Resolution 19:003 authorized the City to apply to join SELACO WDB
- County of Los Angeles and State of California have approved the City of Paramount's transition from the LACO-WDB to SELACO

  - \* Directed by Board of Directors seat at the table
  - \* All member cities part of LA County 4<sup>th</sup> Supervisorial District
  - \* Economic and political partnerships with SELACO cities:

      Gardens, Lakewood and Norwalk
  - \* Consistency in service


 SB1 – Signed by Governor Brown – April 2017

 Funds from Fuel Taxes and Vehicle License Fees.






