WHEREAS, the Successor Agency has studied and discussed the FY 2022-2023 Budget.

NOW, THEREFORE, BE IT RESOLVED BY THE SUCCESSOR AGENCY AS FOLLOWS:

<u>SECTION 1</u>. The above recitations are true and correct.

SECTION 2. That the FY 2022-2023 Budget is hereby approved and adopted as presented and that appropriations shall be made in the following amounts:

<u>SECTION 5</u>. That the Successor Agency hereby directs the City Manager to have the FY 2022-2023 Budget prepared for general distribution.

<u>SECTION 6</u>. The Mayor, or presiding officer, is hereby authorized to affix his/her signature to this resolution signifying its adoption and the City Clerk, or his/her duly appointed deputy, is directed to attest thereto.

<u>SECTION</u> 7. This Resolution shall take effect immediately upon its adoption.
