# Subject: ORAL REPORT – SMALL BUSINESS ASSISTANCE GRANT PROGRAM SUMMARY

An update of the Small Business Assistance Grant Program will be provided. The City of Paramount received American Rescue Plan Act of 2021 (ARPA) funds in the amount of \$18,895,185.00. From the ARPA funds, the City Council allocated funds for grants up to \$20,000 from the City to businesses that were impacted by the COVID-19 pandemic.

Forward (previously known as LiveStories) administered the program and began accepting applications on August 3, 2022. At the conclusion of the program, the City awarded \$672,500 to 40 small businesses. \$16,813 was the average grant amount amount.
