WHEREAS, the Executive Director has prepared the FY 2023-2024 Annual Budget for the Housing Authority (FY 2023-2024 Budget), in accordance with the Paramount Municipal Code, Section 2.08.20(E); and

WHEREAS, the Housing Authority has examined the FY 2023-2024 Budget with the Executive Director; and

WHEREAS, the Housing Authority has studied and discussed the FY 2023-2024 Budget.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSING AUTHORITY AS FOLLOWS:

**<u>SECTION</u> 1**. The above recitations are true and correct.

**SECTION 2**. That the Fiscal Year 2023-2024 Budget is hereby approved and adopted as presented and that appropriations shall be made in the following amounts:

Affordable Housing Projects	\$	302,000
Total Housing Authority Appropriations	<u>\$</u>	302,000

**SECTION 3**. That the above appropriations for the FY 2023-2024 Budget shall be expended by the following fund:

Housing Authority of the City of Paramount	<u>\$</u>	302,000
Total Appropriations by Fund	<u>\$</u>	302,000

**SECTION 4.** That the Housing Authority authorizes and directs the Executive Director, or his/her designee, to make any necessary changes and adjustments to the appropriations during the fiscal year, or to enter into and execute agreements necessary to administer Housing Authority operations and capital improvement projects, or implement the intent of the Housing Authority.

**SECTION 5.** That the Housing Authority hereby directs the Executive Director to have the Fiscal Year 2023-2024 Budget prepared for general distribution.

<u>SECTION 6</u>. The Chair, or presiding officer, is hereby authorized to affix his/her signature to this resolution signifying its adoption and the Executive Director, or his/her duly appointed deputy, is directed to attest thereto.

**<u>SECTION</u>** 7. This Resolution shall take effect immediately upon its adoption.
