## RE: SUPPORT – SB 326 (EGGMAN) BEHAVIORAL HEALTH SERVICES ACT AND AB 531 (IRWIN) BEHAVIORAL HEALTH INFRASTRUCTURE BOND ACT OF 2023

Dear Senator Eggman and Assemblymember Irwin:

The City of Paramount would like to express its support for SB 326 and AB 531, a legislative package supported by Governor Gavin Newsom that will transform the Mental Health Services Act (MHSA). The proposed package aims to enact a \$4.86 billion bond measure to build 10,000 new community behavioral health beds and housing to provide care to Californians of all ages with serious mental health and substance use disorders.

As part of the City's Vision, Mission, and Values, Paramount provides fiscally responsible services that maintain a vibrant, safe, and inclusive community for all individuals.

California is facing a confluence of crises - homelessness, serious mental illness, and substance use disorders - and this moment demands bold and comprehensive action. Among Californians experiencing homelessness, nearly 40,000 have a serious mental illness and over 36,000 have a chronic substance use disorder. A recent RAND study indicates the state has a shortage of at least 6,000 behavioral health beds. This lack of sufficient capacity leads not only to unnecessary long lengths of stays in locked settings and hospitals but contributes to the growing crisis. The need for mental health and substance use services is even more acute among our state's veterans. There are over 10,000 California veterans experiencing homelessness on any given night; upwards of 50% or more of homeless veterans suffer from mental health issues and around 70% are affected by substance use disorders. The proposed bond would dedicate a portion of the funding to provide the support our veterans deserve.

These actions will build upon California's transformative behavioral health care expansion and accomplishments to date, including the CARE Act (formerly Care Court), the Children's and Youth Behavioral Health Initiative, the CalAIM expansion of behavioral health services in Medi-Cal, historic investments in behavioral health housing and infrastructure, veterans' health and housing initiatives, and behavioral health workforce investments – to provide a continuum of community care for all.
