Subject: ORAL REPORT – ECONOMIC IMPACTS OF THE LA WILDFIRES

On January 7, 2025, a handful of wildfires erupted in the Los Angeles region and was fueled by a rare wind event which forecasted wind gusts exceeding 100 miles per hour in some areas. The LA Wildfires arguably became one of the costliest natural disasters in U.S. history. The effects of the LA Wildfires are far reaching and woven into the economic state of Southern California. Most Los Angeles County residents know someone who has been personally impacted by the devastating losses caused by the LA Wildfires. The fires burned for 24 days and stretched our network of emergency response teams thin. As of January 31, 2025, the fires were 100 percent contained.

Rebuilding these communities will take time, resources, and patience. The rebuilding efforts are underway, with the City of Los Angeles mobilizing to set up a one-stop rebuilding center where property owners can obtain information, guidance, and expedited services from multiple agencies. The County of Los Angeles has also launched the Altadena Disaster Recovery Center to help property owners affected by the Eaton Fire navigate and streamline their rebuilding efforts.
