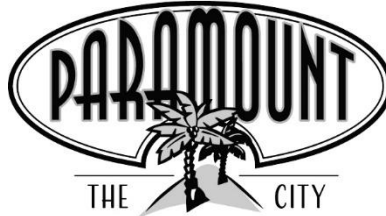

Subject: ORAL REPORT – PARAMOUNT PUBLIC ART UPDATE

In November of 2023, the City Council approved an agreement with Gail M. Goldman and Associates, LLC to prepare the City's first ever Public Art Master Plan. The plan has been completed. Earlier this evening, the Planning Commission heard and approved Zoning Ordinance Text Amendment No. 35, recommending that the City Council adopt an ordinance to repeal and replace Chapter 17.112 in its entirety based on the recommendations outlined in the Public Art Master Plan. The final Public Art Master Plan will be presented to the City Council later this month.
