A housing developer, Gold Key Development, Inc., is applying for City of Paramount approval to construct 17 single-family homes on a 1.04-acre property at 16635, 16675, and 16683 Paramount Boulevard. This location is on the west side of Paramount Boulevard at the border of Paramount and Long Beach. Most of this area is vacant, and two remaining buildings would be demolished. On August 6, 2025, the Development Review Board approved the design of the homes, and the Planning Commission recommended approval of changes to the Paramount General Plan Land Use Map and the Paramount Zoning Map. The City Council will consider changes to these two maps to allow for the homes.
